The SRC offers a globally relevant and recognized programme rooted in Caribbean and Small States realities.

The programme is offered both as a Master's of Science (M.Sc.) degree and a Post-Graduate Diploma that is awarded by the Faculty of Social Sciences of The University of the West Indies' Cave Hill Campus, Barbados.

The Master's Programme is a 12-month full-time course that emphasizes critical thinking on trade policy matters, taught by a unique blend of regional and international scholars, professionals and practitioners.

The Post-Graduate Diploma is a 4-month course offered in the first semester to those wishing to obtain the essentials of trade policy.

In addition to these programmes, courses are also made available individually.

THEORETICAL COMPONENT

For the first 6 months, students learn in a virtual classroom environment about the theories and substantive scope of trade rules from a multi-disciplinary perspective of law, politics, and economics.

The programme provides a uniquely Caribbean perspective which affords students the opportunity to begin thinking about Caribbean responses to global problems and issues.

The core courses are taken in Semester I. In Semester II, students undertake a supervised research paper and four electives.

Core Courses:
